4. Age limit for direct recruitment : 50 years or below (Relaxable upto 5 years for SC/ST candidates)
5. Qualifications: (a) Master's Degree of a recognised University. (b) Minimum 10 years of experience in accounts and general administration. (C) Person with 10 years of administrative experience and who has qualifications comparable to the post of Associate Professor (Reader) may also be considered.
6. Method of recruitment: By transfer/ transfer on deputation (short term contract) failing which by direct recruitment. **Transfer/Transfer on deputation:** (Including short term contract) Persons working in Universities and colleges in India; Central or State Museums and similar institutes and possessing qualifications mentioned in Column 5 above. (Deputation, short term contract shall ordinarily not exceed 3 years).
